Terms & Conditions



CONDITIONS

The conditions agreed shall apply solely between Executive Dogs and the Dog Owner. We do not accept dangerous or unpredictable dogs and unneutered males. Bitches in season may be difficult and there may be occasions where we cannot accommodate them. Dogs must be sociable as they will be in close contact with other boarders and humans.

OPENING TIMES

Our opening times are 7am – 6.30pm Monday – Saturday. We close at 4pm on Sundays. We will require a time that you intend to drop-off and pick-up your dog as we are a small business this may interrupt the routine of the other dogs in our care. We also need to cater for your dogs arrival, and the socialisation with other dogs staying. Please be kind enough to inform us of any changes to agreed arrival times and or delays as soon as possible.

Christmas Opening Hours:

Christmas Eve: 9am – midday

Christmas Day: Closed (for dropping off and collections)

Boxing Day: 9am – midday

New Year's Eve: 9am – midday

New Year's Day: 9am – midday

FEES

Our fees are:

£23 per dog per day or £18 per dog for day care.

If collected after 10.30am, a daily rate of £18 per dog will apply. A deposit of 50% is required to secure the booking. Any outstanding balance must be paid on arrival of the dog(s). We accept cheques, cash or PayPal. **We cannot accept credit or debit cards.** All cheques must be made payable to **Amanda MacGregor**. Receipts will be provided. Fees are inclusive of all food.

Christmas Fees: from the 24th December – 2nd January inclusive, our fees will rise to £28 per dog per day.

ADDITIONAL CHARGES

In the unlikely event that your dog requires veterinary attention, the fees will be payable in full on the collection of your dog. Executive Dogs are fully insured for any illness or injuries that may occur during your dogs’ stay however the owner will be held responsible for any charges relating to any ongoing illness or treatment that occurred prior to the dogs’ stay.

OWNER’S UNDERTAKING

The owner agrees in full that the dogs will be housed with dogs from other households, and that their dog has not been exposed to rabies or distemper and has been vaccinated against rabies, distemper, rhino-tracheitis, trachea-bronchitis, parvo-virus and kennel cough and that such vaccinations are in date for the duration of the stay.

The owner confirms that the dog has never attacked another animal or human nor that there are no details which have been withheld which, if disclosed to Executive Dogs, would be reasonably expected to affect them in entering such an agreement.

The owner agrees that all details in the Booking Form are correct in every respect.

The owner must present a valid vaccination card for each dog on the arrival of their stay at Executive Dogs.

In the event of any unforeseen circumstances, the owner agrees that Executive Dogs are fully entitled to make any decisions which they deem to be suitable to resolve the matter.
